



Becky's School of Dance 2011-2012 Parent/Dancer Contract

I, (parent or legal guardian name), \_\_\_\_\_ understand that by signing this contract I am enrolling my child(ren) in the dance program offered by Becky's School of Dance. I also understand that by signing this contract I understand and agree to the following:

Please initial each:

\_\_\_\_ I understand that my child is enrolling into a program that requires a time commitment and attendance for approximately 9 months.

\_\_\_\_ I understand that my child is enrolling in a program that may pose certain incumbent risks, and that neither Becky's School of Dance, Becky Thayer, nor any teachers are responsible for injury.

\_\_\_\_ I understand it is my responsibility to inform instructors of any medical conditions, special needs or health issues that may hinder my child's experiences with classes or recitals, or that may pose a personal risk to their health or well-being.

\_\_\_\_ I understand that I am responsible for paying tuition on time each month. If tuition is paid late, I understand that tuition fees are subject to late fees as well as restrictions on participation by my child in the program.

\_\_\_\_ I understand that if past due accounts are not taken care of within 2 weeks, or other time specified by Becky Thayer my child may be expelled from any participation within the program.

\_\_\_\_ I understand that all monthly tuition (with the exception of August and January) are due upon the first day of each month, not the first day of class each month.

\_\_\_\_ I understand that costume fees of \$125 for general classes and \$325 for competition classes are due by Monday, Sept 26th. These costume fees will cover both Christmas and Spring Recital costuming and/or competition class costumes with the exception of solos, duo/trios and small groups. These fees also will include the price of tights. Costume fees are applied to costumes and coordinating tights for recitals only.

\_\_\_\_ I understand that costume fees are non-refundable. Costumes are non-returnable.

\_\_\_\_ I understand that shoes, dancewear, practice tights, and other extras are my responsibility to pay for at time of placing order, and are additional costs above and beyond costume fee.

\_\_\_\_ I understand that fundraising opportunity for my child's costume fees are available. I also understand that these opportunities are strictly voluntary and are not required.

\_\_\_\_ I understand that fundraising done by my child will only be applied to my child's costume expenses. Fundraising is not a collective effort. It is strictly for the benefit of the person doing the fundraising (with the exception of some competition fundraisers)

\_\_\_\_ I understand that if I partake in fundraising for costume fees, I am responsible to turn in orders, one check written to BSD for all orders taken and balance due on costume fees by or before Monday, September 26<sup>th</sup> 2010.

\_\_\_\_ I understand that with my child's involvement in this program I may be asked to volunteer time or talents.

\_\_\_\_ I understand that I am only being given one free vip ticket per recital per child.

\_\_\_\_ I understand that extra activities extended to the dance program may be offered for my child, but are strictly voluntary (Special Appearances).

\_\_\_\_ I understand it is my responsibility to mark all articles of clothing, shoes, bags, etc. with my child's name. Lost or stolen personal items are not the responsibility of BSD.

\_\_\_\_ I understand that it is my responsibility to check the communication boards, website, facebook page and emails for new information pertaining to my child's classes. There may be periods of time where there is little new information and periods of time where there may be a lot. It is sometimes easy to miss something.

\_\_\_\_ I understand it is my responsibility to sign up for email alerts with [michelled@beckysschoolofdance.com](mailto:michelled@beckysschoolofdance.com). I understand I will not automatically be signed up for alerts.

\_\_\_\_ I understand it is my responsibility to "Like" Becky's School of Dance on Facebook and will not automatically be alerted of Facebook updates.

\_\_\_\_ I understand the lobby, bathrooms and practice studios are used for all to enjoy. It is my responsibility to make sure it is left in a clean and orderly fashion after using lobby, bathroom, etc.
